The Tampa House also serves families at St. Joseph's Hospital for Children and Shriners Hospital. There are 80 bedrooms and private baths within our four Houses. Geographically we serve families from every county in Florida, every state in the U.S.A. and an average of 18 countries.

Services are provided to families. Actual operating costs are \$65 per night per room. No one is turned away because of an inability to donate. Families staying at the St. Petersburg and Tampa Houses are provided with the following amenities:
